### **Update on Pittsboro Town Commission and holding Chatham Park Investors Accountable**

ChathamCAN continues to urge the Pittsboro Board of Commissioners to stand firm on rejecting Chatham Park Investors' (CPI) proposal to substitute one massive plan in place of the 16 small area plans in the South Village originally proposed. The proposal was presented to the Town Planning Board at their last meeting on September 15th. They now have 60 days to make a recommendation to the Board of Commissioners to approve or reject the current plan. Please consider attending any of the following meetings to learn more and show your concern about the direction of this hugely influential development in Chatham county:

- Monday, October 6th @ 6pm Ag Center - Town Planning Board Work Session on Chatham Park's South Village Small Area Plan
- Monday, October 13th @ 6pm Ag Center - Town Board of Commissioners (agenda to be determined, but will likely involve more discussion of the South Village Small Area Plan)
- Monday, October 20th @ 6pm Ag Center - Planning Board meeting (vote on recommendation to the Board of Commissioners likely at this meeting likely).
